- V. Committee Reports

Tom Esperiqueta, committee chair for the restructuring of the Constitution and ByLaws
Submitted a reorganized layout of the current version of the TECA Constitution
Ed Gonzales, committee chair for the restructuring of the Solo and Ensemble Classification

"Within the last few years, the subject of the validity of the Solo and Ensemble competition has become an issue with some of TECA's members. Most of the concern stems from the lack of consistency between sites (which causes later and later contests) and the lack of consistency with posted schedules (which also causes later and later contests.) The committee members who provided input came to the following conclusions.

TECA should keep the Solo and Ensemble portion of competition. It wouldn't be educational to subtract any performance opportunity which enhances the performance level of any performing member; however, since this issue keeps surfacing, restructuring or reformation may need to occur.

There are two possible scenarios that were agreed upon...

Keep S&E Contests as is, but limit the size of the unit contest based on the size of the facility.

Have one S&E contest in San Antonio, one contest in Laredo and one Contest in the RGV area with S&E Championships in late Feb/early March. This would null and void the "2 performance scores" for Championship requirements."

Outcome: TECA will keep the Solo and Ensemble Classification this year but limit entries based on size of venue. Next year (2009-2010 season), TECA will offer I Solo and Ensemble Contest in Laredo, RGV and San Antonio with Championships mid season. This will eliminate performance requirements for state qualification, but a minimum score will be required to advance to the State Competition.

Article VI section A number 3

Currently reads:

Personnel changes (students) render them noncompetitive in the Scholastic Divisions. It is the responsibility of the unit director to inform the President of the Texas Educational Colorguard Association, in writing, of this situation.

Amend to:

As the TECA follows all UIL/TEA eligibility rules, a roster listing all eligible performing members in a unit must be turned in by each competing guard at their first performance of the season. This roster must be signed by the Principal (Scholastic Units) or the guard director (Non-Scholastic Units) and must be updated as unit membership or eligibility changes.
