  - Have not been able to complete taxes since becoming corp.
  - 1200.00 state taxes paid only 120.00. We don't have treasurer reports from prior treasurer.
  - Working on the federal taxes hopefully will be paid off before the start of the next season.
  - New system set with 2 person signature requirement for new checking account.
  - 2011 season was \$6,000.00 in deficit. This year that debit has been paid off and still have a surplus.

  - a. Looking for sound tech 10 weeks. Need contest director for 10 weeks. TECA will provide all sound system equipment.
  - b. Registration will be completely paperless. Once registration is filled out no forms will be needed to bring in to contest. Eligibility will be the only form that needs updating as needed.
